APPROVAL OF MINUTES

The minutes of the June 21, 2018 meeting stand approved as submitted.

RECOMMENDATION TO APPROVE, IF AWARDED, INFANT & EARLY CHILDHOOD MENTAL HEALTH GRANT PROGRAM (GOAL 2) Melody Palmer-Arizola gave an overview of the grant which will provide \$500k/yr. for 5 years with a \$50k match. The grant will serve 125 kids the first year and 200 kids years 2 -5. Discussion ensued. Sarah Churchill Llamas called for a motion to recommend to the Board the approval of proposed recommendation. Dr. Guadalupe Zamora second. All in favor. Motion carried. *This item will be added to the consent agenda*.

RECOMMENDATION TO APPROVE, IF AWARDED, HEALTH & HUMAN SERVICES – ADMINISTRATION FOR COMMUNITY LIVING INNOVATIONS IN NUTRITION PROGRAMS AND SERVICES (GOAL 2) Teresa Williams gave an overview of the grant which will provide \$500k for 2 years. It will begin on September 30. 2018 and will target adults 60+ with serious mental illness and chronic health conditions. Discussion ensued. Sarah Churchill Llamas called for a motion to recommend to the Board the approval of proposed recommendation. Dr. Guadalupe Zamora second. All in favor. Motion carried. *This item will be added to the consent agenda*.

DISCUSSION ITEM: CHIEF OPERATIONS OFFICER (COO) REPORT

Dawn Handley provided the Committee with a brief verbal report regarding clinical service delivery and program support. Discussion ensued.

Background

- A Request for Proposal for Residential Services was released on June 18, 2018.
- This proposal included both crisis respite and crisis residential services.
- Procurement of these services is part of Integral Care's Local Provider Network Plan (LPND)
- The Planning and Network Advisory Committee (PNAC) recommended approval to the Board on August 9, 2018



Requirements for LPND

- House Bill 2439 (2007): Calls for a system of service in which consumers have choice from multiple providers
- Requires all Local Mental Health Authorities (LMHAs) to assemble a network of service providers by:
- · Providing management and oversight
- Ensuring mental health services are provided in their local area
- Serve as a provider of last resort, and
- Consider public input, cost-benefit and consumer issues



Crisis Respite Services (Next Steps)

PROJECTED WORKLOAD:

The Services will be provided within Integral Care's facility. A maximum occupancy of 31 crisis residential beds will be provided under this RFP. The Clients utilizing these beds reside in Travis County and are eligible to receive Services from or through the Local Authority.



Crisis Respite Services (Next Steps)

PROJECTED WORKLOAD (cont.):

The Successful Proposer(s) will provide short term (up to 14 consecutive days per stay) crisis respite services to individuals referred. A Successful Proposer must provide Services that include twenty-four (24) hour on-site supervision and structured activities.



Hopkins Crisis Residential Services

PROJECTED WORKLOAD:

The Services will be provided within Integral Care's facility. A maximum occupancy of 16 crisis residential beds will be provided under this RFP. The Clients utilizing these beds reside in Travis County and are eligible to receive Services from or through the Local Authority.



Hopkins Crisis Residential Services

PROJECTED WORKLOAD (cont.):

The Successful Proposer(s) will provide short term (up to 7 consecutive days per stay) crisis residential services to individuals referred. A Successful Proposer must provide Services that include twenty-four (24) hour on-site supervision and structured activities.

- Focus on Downtown and West Campus areas
- Current contract with DACC to fund existing HOST members for Integral Care
- Identified need for additional resources

- Funding will provide a peer specialist for HOST and flexible client assistance

Grant Submission

- The mandate of the Religious Coalition to Assist the Homeless, per an Austin City Council ordinance passed in February 1996, is to fund agencies that provide beds to people who are homeless.
- Funding limited to Austin service providers who will use the funds to shelter people who are homeless and/or assist and support people who are homeless in securing and remaining in permanent housing.
- Due date August 10, 2018
- Renewal and expanded request



Details of proposed project

- Provide funding for two staff within Supported Housing Teams that focus on income and financial stability
 - SOAR Specialist
 - Supported Employment Specialist
- Existing positions currently funded by Episcopal Health Foundation looking for additional sources to sustain
- Allows for individuals recently housed to gain income, access to benefits (i.e. Medicaid), and improve their overall quality of life

- 100 Chronically Homeless Individuals who are frequent users of public services
- Identified through a list comprised of utilization of jail, emergency rooms, psychiatric facilities, etc.
- This project will provide specialized services for women experiencing homelessness.
