CITIZENS' COMMENTS

Grace Matthews, an attorney with Baker Botts introduced herself and informed the Board that she will be representing a client experiencing homelessness. Rachel Gunner, Integral Care Foundation President, updated the Board on meeting their fundraising goals.

CHAIR'S WELCOME

Chair Katz recognized the Integral Care Foundation for their hard work. Chair Katz also informed the Board Members that Trustee David Springer has been named Interim Dean at the LBJ School of Public Affairs at the University of Texas at Austin.

ACTION ITEMS

Following introductions, and in accordance with Texas Government Code Annotated, Section 551.074 PERSONNEL MATTERS, the meeting went into closed session to conduct the annual performance evaluation of the Chief Executive Officer.

When the meeting reconvened in open session, it was moved that the Board approve the Chief Executive Officer's Evaluation, Compensation and FY21 Goals as Presented. The vote was taken and the motion carried.
