

# **Request for Applications**

#### I. Introduction

Integral Care seeks to collaborate with local individuals and organizations to strengthen our contracted community provider network.

We want to ensure that Integral Care and its diverse network of contracted community-based providers can meet the unique needs of all individuals seeking mental health, substance use disorder, and intellectual and developmental disability services throughout our service area.

To support our Vision of "Healthy Living for Everyone," Integral Care is committed to supporting the health and well-being of adults and children throughout Travis County. Integral Care proudly improve the lives of individuals affected by behavioral health and developmental and/or intellectual challenges by providing innovative and quality services.

Network providers are key to the overall success of the individuals who depend on our agency for their healthcare needs. Integral Care is seeking applications from individual and organizational providers in support of our agency goals to:

- 1. Deliver accessible and timely care to meet community needs.
- 2. Provide equitable access to prevention, treatment, and recovery services.
- 3. Create an inclusive and culturally competent staff and contracted provider base that reflects the community and clients receiving services from Integral Care.

#### II. General Information

AUSTIN-TRAVIS COUNTY MENTAL HEALTH AND MENTAL RETARDATION CENTER, dba INTEGRAL CARE "Integral Care" or "Local Authority" (Local Mental Health Authority 'LMHA' and Local Intellectual and Developmental Disability Authority 'LIDDA') is the Texas Health and Human Services ("HHS") designated authority established to plan, coordinate, develop policy, develop and allocate resources, supervise, and ensure the provision of community-based mental health and intellectual and developmental disability (IDD) services for the residents of Travis County, Texas. Integral Care receives funding from many diverse sources that enables it to provide a variety of services for people who have needs related to behavioral health and/or intellectual/developmental disabilities.



#### Integral Care's Mission:

To improve the lives of people affected by behavioral health and developmental and/or intellectual challenges.

#### Integral Care's Vision:

Healthy Living for Everyone

Pursuant to 25 Texas Administrative Code §412.55 and 40 Texas Administrative Code §2.55, the LMHA and LIDDA have the authority to acquire services to address needs of mental health and/or intellectual/developmental disabilities needs by certain procurement methods. This Request for Applications (RFA) invites and encourages the submission of applications (each, an "Application" and collectively, the "Applications," and any party applying, an "Applicant") from those interested in entering one or more contracts (each a "Contract" and collectively the "Contracts") with Integral Care. Each qualified Applicant(s) under this RFA (each a "Successful Applicant" and collectively, the "Successful Applicants") will be eligible to enter a Contract with Integral Care to provide one or more of the community-based services more specifically described in Section VII of this RFA. ("Services").

The individuals who will be served under this arrangement (each, a "Client" and collectively, "Clients") must always (a) meet the then-current requirements of the funder of the services, and (b) reside in Travis County, Texas. An individual's designation as a Client may only be made by the Local Authority and must be documented in their record. This RFA invites the submission of Applications from those interested in being considered for a Contract with Integral Care for the purpose of offering Services for Clients.

#### Integral Care's Board of Trustees and local leadership are committed to:

## **III.** Eligibility Requirements

To be eligible to receive a Contract with the Local Authority, an Applicant must:

- 1) Demonstrate the ability to provide Services in compliance with Local Authority's Contract requirements.
- 2) Comply on an ongoing basis with the then-current version of Local Authority's Provider Manual. The most up-to-date version of the Provider Manual can be found on Integral Care's website.
- 3) Meet minimum training, educational, licensing and credentialing requirements for Services delivered under this RFA, as described in this RFA.



- 4) Provide official documentation indicating that Applicant and, as applicable, each employee of Applicant who will provide Services, has undergone screening for tuberculosis within the prior year and thereafter complete such screening on an annual basis. Applicant shall also follow Local Authority's policies and procedures for further requirements if screening results in a positive reading.
- 5) Be eligible or registered to do business in Texas.
- 6) Meet minimum training, educational, licensing and credentialing requirements described in this RFA for Service delivered under this RFA.

### **IV: Required Provider Training**

To be eligible to provide Services under a Contract with Integral Care, a Successful Applicant is required to, among other things, successfully complete mandatory pre-Services training in 1.) Client Rights, Abuse, Neglect, Exploitation, Client Grievance, 2.) HIPAA/Confidentiality, 3.) Infection Control, 4.) Corporate Compliance, 5.) CPR, and 6.) Standard First Aid. Successful Applicants who receive a Contract must also complete refresher trainings annually. Some pre-Services training and annual refresher training may be completed in class at Integral Care, some may be taken through a third-party vendor, and some may be completed by accessing Integral Care's web-based training. Information on options for completing required pre-Services training, as well as information on any additional training requirements specific to the Service(s) to be considered for inclusion in the Contract, will be sent to each Successful Applicant once the Application has been received and processed.

Integral Care does not reimburse Applicants or Contracted Providers for any costs associated with required pre-Services or annual training. Time spent completing required pre-Services and annual refresher training is not billable to Integral Care.



## **V: Responsibilities**

#### Local Authority Responsibilities

The Local Authority will ensure provision of service coordination/case management to most Clients and facilitate a Client's selection of service providers, authorize Services, review claims and pay for appropriate authorized services rendered by the service providers in its network. The Local Authority is also responsible for utilization management and quality assurance. The Local Authority ensures that contracted Services addressing client needs are provided as required by HHS and other funders. The Local Authority does not guarantee that any referrals will be made to any service provider within its network of providers. The Local Authority ensures these provisions with an understanding there may be specific responsibilities that differ for certain service providers.

#### Service Provider Responsibilities

Each Successful Applicant must submit all original documentation reflecting Services provision and will maintain additional secondary records regarding Services rendered to Clients and allow the Local Authority access to such records upon request. Each Successful Applicant is required to comply with all state and federal laws regarding the confidentiality of Clients' records and nondiscrimination. Successful Applicants providing Services will actively assist in the disbursement of Client and advocate satisfaction surveys, and will obtain prior authorization, provide acceptable levels of care, and maintain acceptable levels of liability insurance, and appropriate licenses and accreditations. Each Successful Applicant name, contact information and certain other pertinent information may be used, along with a description of its facilities, care, and Services, in any information distributed by the Local Authority listing its service providers. Successful Applicants must comply with the rules and standards adopted under Section 534.052 of the Texas Health and Safety Code, applicable local, state, and federal laws, rules and regulations, and the applicable contract between the Local Authority and HHS and/orany other funding entity, as applicable.



## **VI: Instructions for Submission of Applications**

To facilitate and ensure an objective review, Applicants must follow the instructions below regarding Application submission. Integral Care reserves the right not to evaluate any Application that is not submitted according to the following instructions.

Applicants must submit the completed Application online via the appropriate form (e.g., Application for Individuals or Application for Organizations). Applications will be processed upon receipt. In the future, other open enrollment periods for various services may be announced to ensure availability of adequate numbers of Services providers to meet the volume of demand for those Services. False statements or information provided by an Applicant may result in disqualification from or termination of enrollment into the network. The Local Authority reserves the right to reject Applications, to waive technicalities, and to accept any advantages deemed beneficial to the Local Authority and the Clients. Each Applicant is responsible for ensuring that documents are submitted completely and within the time frame specified by Integral Care. The Local Authority expressly reserves the right not to evaluate any Application documents that are incomplete or late.

Each Application may be disclosed as provided by the Texas Public Information Act, Chapter 552 of the Texas Government Code, and any other applicable laws, rules and/or regulations. Applicants must clearly identify any claimed trade secrets and confidential information contained in the Application.



## VII: Services/Rates

Applicant agrees that, if chosen to receive a Contract, it will accept the fees listed below as payment in full for approved Services contained within the Contract. Credentialing is required for submission of claims, bills, and to receive compensation for Services. Successful Applicants shall ONLY submit a claim or bill or collect compensation from Local Authority for any Services for which it has submitted an Application, been approved, and given a Contract to provide. Applicant agrees that compensation for providing services not covered by its approved Application and Contract will be solely between the Client and the Applicant, and subject to the Contract terms. The Client must be informed in writing of his/her obligation to pay for services not included in Applicant's Contract before they are provided, and that the Local Authority is not responsible for payment for such services.

#### **Attachment B: Bars to Employment/Contracting**

The names of all Integral Care prospective employees and contract providers are cleared through a preemployment/contracting criminal history and registry clearance. The clearance will search data from the Texas Department of Public Safety, Crime Records Division Criminal History Search, the U.S. Department of Health and Human Services Office of the Inspector General (OIG) List of Excluded Individuals, Texas Health and Human Services, OIG Exclusions List, the DADS Nurse Aide Registry and Employee Misconduct Registry, and the DSHS Client Abuse and Neglect Reporting System ("CANRS"). Additionally, a Federal Bureau of Investigation (FBI) fingerprint clearance is conducted for those individuals who have resided outside the state of Texas within the two years immediately prior to the Application date or whose services will be funded through the Child and Family Services System of Care. A conviction for any of the offenses listed below is a bar to employment with and to providing services under a Contract with Local Authority:

- (a) A person for whom the facility or the individual employer is entitled to obtain criminal history record information may not be employed in a facility or by an individual employer if the person has been convicted of an offense listed in this subsection:
- (1) an offense under Chapter 19, Penal Code (criminal homicide);
- (2) an offense under Chapter 20, Penal Code (kidnapping and unlawful restraint);
- (3) an offense under Section 21.02, Penal Code (continuous sexual abuse of young child or children), Section 21.11, Penal Code (indecency with a child);
- (4) an offense under Section 22.011, Penal Code (sexual assault);
- (5) an offense under Section 22.02, Penal Code (aggravated assault);
- (6) an offense under Section 22.04, Penal Code (injury to a child, elderly individual, or disabled individual);
- (7) an offense under Section 22.041, Penal Code (abandoning or endangering child);
- (8) an offense under Section 22.08, Penal Code (aiding suicide);
- (9) an offense under Section 25.031, Penal Code (agreement to abduct from custody);
- (10) an offense under Section 25.08, Penal Code (sale or purchase of a child);
- (11) an offense under Section 28.02, Penal Code (arson);
- (12) an offense under Section 29.02, Penal Code (robbery);
- (13) an offense under Section 29.03, Penal Code (aggravated robbery);
- (14) an offense under Section 21.08, Penal Code (indecent exposure);
- (15) an offense under Section 21.12, Penal Code (improper relationship between educator and student);



- (16) an offense under Section 21.15, Penal Code (improper photography or visual recording);
- (17) an offense under Section 22.05, Penal Code (deadly conduct);
- (18) an offense under Section 22.021, Penal Code (aggravated sexual assault);
- (19) an offense under Section 22.07, Penal Code (terroristic threat);
- (20) an offense under Section 33.021, Penal Code (online solicitation of a minor);
- (21) an offense under Section 34.02, Penal Code (money laundering);
- (22) an offense under Section 35A.02, Penal Code (Medicaid fraud);
- (23) an offense under Section 36.06, Penal Code (obstruction or retaliation);
- (24) an offense under Section 42.09, Penal Code (cruelty to livestock animals) or under Section 42.092, Penal Code (cruelty to nonlivestock animals); or
- (25) a conviction under the laws of another state, federal law, or the Uniform Code of Military Justice for an offense containing elements that are substantially similar to the elements of an offense listed under this subsection.
- (b) A person may not be employed in a position the duties of which involve direct contact with a client in a facility or may not be employed by an individual employer before the fifth anniversary of the date the person is convicted of:
- (1) an offense under Section 22.01, Penal Code (assault), that is punishable as a Class A misdemeanor or as a felony;
- (2) an offense under Section 30.02, Penal Code (burglary);
- (3) an offense under Chapter 31, Penal Code (theft), that is punishable as a felony;
- (4) an offense under Section 32.45, Penal Code (misapplication of fiduciary property or property of a financial institution), that is punishable as a Class A misdemeanor or a felony;
- (5) an offense under Section 32.46, Penal Code (securing execution of a document by deception), that is punishable as a Class A misdemeanor or a felony;
- (6) an offense under Section 37.12, Penal Code (false identification as peace officer); or
- (7) an offense under Section 42.01(a)(7), (8), or (9), Penal Code (disorderly conduct).

In addition, Integral Care will not enter into a Contract with an Applicant that:

1. Has been convicted of other types of criminal offenses that may be considered a contraindication to contracting with Local Authority, in Local Authority's sole discretion;



- 2. Is listed as "revoked" in the Nurse Aide Registry;
- 3. Is listed as "unemployable" in the Employee Misconduct Registry; or
- 4. Is listed as having a confirmed finding with CANRS.

No applicant will be contracted, or allowed to provide contracted services, if the application is falsified in any way. Falsification of the application for contracting, or provision of contracted services, is grounds for contract termination.

#### **Attachment C: E-Verify**

E-verify is an Internet-based system that allows businesses to determine the eligibility of individuals to work in the United States. Integral Care requires proof of US citizenship and/or other authorization required by law to legally work in the United States. Organizational applicants are required to submit I-9 verification information through the E-verify system on each organizational group member applying for credentialing under the contract. Individuals applying for contracting will be required to show original I-9 documents and sign the I-9 form in person at Integral Care. For a list of acceptable I-9 documents go to: https://www.uscis.gov/i-9-central/acceptable-documents. Integral Care will provide the Social Security Administration (SSA) and, if necessary, the Department of Homeland Security (DHS), with information from each prospective individual contractor's Form I-9 to confirm work authorization through the E-verify System.

# Attachment E: Safe Driving Standard – Poor Driver Guidelines

These guidelines apply to any Successful Applicant who will drive an automobile that transports Clients as part of any Services under a Contract with Integral Care.

If any Successful Applicant has four (4) or more points based on this list, they CANNOT TRANSPORT CLIENTS.

Listed below are guidelines that the Texas Council Risk Management Fund, which provides liability insurance for Integral Care, follows to determine whether someone is a "poor driver" from review of the motor vehicle record or driver's record from the Texas Department of Public Safety ("MVR"). Integral Care follows these guidelines for Successful Applicants who will drive an automobile that transports Clients, whether as part of or incidental to the Contract services.

Based on a point system, a driver with four (4) or more points (as indicated below) is considered a "poor driver." Please note that if a driver can provide an accident report clearly showing that the driver was not at fault for an accident violation, two points will not be assessed. Applicants who intend to provide services through the Applicant's employees ("Organizations") need to request each such employee's



driver record from the Texas Department of Public Safety and review those records against the guidelines above. Applicants who are not Organizations must request their own Texas DPS driver's record and submit a copy to Integral Care's Credentialing Department. Here are the guidelines used to determine a "poordriver".

Driving while intoxicated (DWI)	4 points
Driving under the influence (DUI)	4 points

Incidents involving a <i>No Motor Vehicle Insurance</i> violation and a moving violation on the same day	2 points
Incidents involving BOTH an at-fault accident AND a <i>No Motor Vehicle Insurance</i> Violation	4 points
Drug Offense	4 points
All MVRs that come back with a driver's license status of EXPIRED, DENIED,	Automatic
CANCELLED, SUSPENDED, or REVOKED	Exclusion
