

Request for Applications

I. General Information

AUSTIN-TRAVIS COUNTY MENTAL HEALTH AND MENTAL RETARDATION CENTER, dba INTEGRAL CARE “Integral Care” or “Local Authority” (Local Mental Health Authority ‘LMHA’ and Local Intellectual and Developmental Disability Authority ‘LIDDA’) is the Texas Health and Human Services (“HHS”) designated authority established to plan, coordinate, develop policy, develop and allocate resources, supervise, and ensure the provision of community-based mental health and intellectual and developmental disability (IDD) services for the residents of Travis County, Texas. Integral Care receives funding from varied sources that enables it to provide a variety of services for people who have needs related to behavioral health and/or intellectual/developmental disabilities.

Integral Care’s Mission:

To support the health and well-being of Travis County residents living with mental health challenges, substance use disorders, and intellectual and developmental disabilities.

Integral Care’s Vision:

Mental Health and Well-Being for Everyone

Pursuant to Texas Health and Safety Code Sections 534.054 and 534.105, the LMHA and LIDDA have the authority to acquire services to address mental health and/or intellectual/developmental disabilities needs in their service area by certain procurement methods. This Request for Applications (RFA) invites and encourages the submission of applications (each, an “Application” and collectively, the “Applications,” and any party applying, an “Applicant”) from those interested in entering one or more contracts (each a “Contract” and collectively the “Contracts”) with Integral Care. Each qualified Applicant(s) under this RFA (each a “Successful Applicant” and collectively, the “Successful Applicants”) will be eligible to enter a Contract with Integral Care to provide one or more of the community-based services more specifically described in Section VII of this RFA. (“Services”).

The individuals who will be served under this arrangement (each, a “Client” and collectively, “Clients”) must always (a) meet the then-current requirements of the funder of the Services, and (b) reside in Travis County, Texas. An individual’s designation as a Client may only be made by the Local Authority and must be documented in their record.

This RFA invites the submission of Applications from those interested in being considered for a Contract with Integral Care for the purpose of offering Services for Clients.

II. Eligibility Requirements

A Successful Applicant must do the following in order to become a contracted provider on Integral Care’s network (“Contracted Provider”):

- 1) Demonstrate the ability to provide Services in compliance with Local Authority’s Contract requirements.
- 2) Comply on an ongoing basis with the then-current version of the Local Authority’s Provider Manual. The most up-to-date version of the Provider Manual can be found on Integral Care’s website.
- 3) Meet minimum training, educational, licensing and credentialing requirements for Services delivered under this RFA, as described in this RFA.
- 4) Provide official documentation indicating that Successful Applicant and, as applicable, each employee of Successful Applicant who will provide Services, has undergone screening for tuberculosis within the prior year and thereafter complete such screening on an annual basis. Successful Applicant shall also follow Local Authority’s policies and procedures for further requirements if screening results in a positive reading. Tuberculosis screening is not required for Applicants seeking to provide virtual only or telehealth only services.
- 5) Notwithstanding the above, Applicants must be eligible or registered to do business in Texas. In any situation where a consortium of providers plans to submit a single Application in response to this RFA, a single entity responsible for Services must be identified to be the party to the Contract, and must demonstrate, to the Local Authority’s reasonable satisfaction, the ability to manage funds.

III. Required Provider Training

In order to be eligible to provide Services under a Contract with Integral Care, a Successful Applicant is required to, among other things, successfully complete mandatory pre-Services training in 1) Client Rights, Abuse, Neglect, Exploitation, Client Grievance, 2) HIPAA/Confidentiality, 3) Infection Control, 4) Corporate Compliance, 5) CPR, and 6) Standard First Aid. Additional trainings may be required from Applicants depending on the Services that the Applicant is seeking to provide. Successful Applicants must also complete refresher trainings annually. Information on options for completing any assigned trainings will be sent to the Applicant once the Application has been receiving and processed.

Time spent completing required pre-Service and annual refresher training is not billable to Integral Care. Successful Applicants may be eligible for training reimbursement stipends depending on the Services that the Applicant is seeking to provide.

IV. Responsibilities

Local Authority Responsibilities

The Local Authority will ensure provision of service coordination/case management and facilitate a Client's selection of Service providers, authorize Services, review claims and pay for appropriate, authorized Services rendered by Service providers in its network. The Local Authority is also responsible for utilization management and quality assurance. The Local Authority ensures that contracted Services addressing client needs are provided as required by Texas Health and Human Services (HHS), and other funders. The Local Authority does not guarantee that any referrals will be made to any service provider within its network of providers.

Service Provider Responsibilities

Each Successful Applicant must submit all original documentation reflecting Services provision and will maintain additional secondary records regarding treatment and/or Services rendered to Clients and allow the Local Authority access to such records upon request. Each Successful Applicant is required to comply with all state and federal laws regarding the confidentiality of Clients' records and nondiscrimination. Successful Applicants providing Services will actively assist in the disbursement of Client and advocate satisfaction surveys, and will obtain prior authorization, provide acceptable levels of care, maintain acceptable levels of liability insurance, and appropriate licenses and accreditations. Each Successful Applicant also agrees that its name, contact information and certain other pertinent information may be

used, along with a description of its facilities, care, and Services, in any information distributed by the Local Authority listing its Service providers. Successful Applicants must comply with the rules and standards adopted under Section 534.052 of the Texas Health and Safety Code, applicable local, state, and federal laws, rules and regulations, and the applicable contract between the Local Authority and HHS and/or any other funding entity, as applicable.

V. Instructions for Submission of Applications

To facilitate and ensure an objective review, Applicants must follow the instructions below regarding Application submission. Integral Care reserves the right not to evaluate any Application that is not submitted according to the following instructions.

Applicants must submit the completed Application online via the appropriate form (e.g., Application for Individuals or Application for Organizations). Applications will be processed upon receipt. In the future, other open enrollment periods for various services may be announced to ensure availability of adequate numbers of Service providers to meet the volume of demand for those Services.

False statements or information provided by an Applicant may result in disqualification from or termination of enrollment into the network. The Local Authority reserves the right to reject any and all Applications, to waive technicalities, and to accept any advantages deemed beneficial to the Local Authority and/or the Clients.

Each Applicant is responsible for ensuring that documents for potential enrollment are submitted completely and within the time frame specified by Integral Care. The Local Authority expressly reserves the right not to evaluate any Application documents that are incomplete or late.

Each Application shall be subject to disclosure as provided by the Texas Public Information Act, Chapter 552 of the Texas Government Code, and any other applicable laws, rules and/or regulations.

Applicants must clearly identify any claimed trade secrets and confidential information contained in the Application.

VI. Services/Rates

Applicant agrees that, if chosen to receive a Contract, it will accept the fees listed below as payment in full for approved Services contained within the Contract. Credentialing is required for submission of claims, bills, and to receive compensation for Services. Contracted Providers shall ONLY submit a claim or bill or collect compensation from Local Authority for any Services for which it is authorized to provide in its Contract. Applicant agrees that compensation for providing services not covered by any Contract that it receives will be solely between the Client and the Applicant, and subject to the Contract terms. The Client must be informed in writing of his/her obligation to pay for services not included in a Contracted Provider's Contract before they are provided, and that the Local Authority is not responsible for payment for such services. The rates listed below are set by state and federal government regulations and/or other third party requirements. Integral Care does not have the authority to set or alter these rates. The Services outlined herein do not represent an exhaustive list. Integral Care remains open to considering additional therapeutic service modalities that are evidence-based or demonstrate potential to meet the evolving needs of Clients.

Attachment B: Bars to Employment/Contracting

The names of all Integral Care prospective employees and Contracted Providers are cleared through a criminal history and registry clearance. The clearance will search data from the Texas Department of Public Safety, Crime Records Division Criminal History Search; the U.S. Department of Health and Human Services Office of the Inspector General (OIG) List of Excluded Individuals; Texas Health and Human Services, OIG Exclusions List; the DADS Nurse Aide Registry and Employee Misconduct Registry, and the DSHS Client Abuse and Neglect Reporting System ("CANRS"). Additionally, a Federal Bureau of Investigation (FBI) fingerprint clearance is conducted for those individuals who have resided outside the state of Texas within the two years immediately prior to the Application date or whose services will be funded through the Child and Family Services System of Care. A conviction for any of the offenses listed below is a bar to employment with and to providing Services under a Contract with Local Authority:

(a) A person for whom the facility or the individual employer is entitled to obtain criminal history record information may not be employed in a facility or by an individual employer if the person has been convicted of an offense listed in this subsection:

- (1) an offense under Chapter 19, Penal Code (criminal homicide);
- (2) an offense under Chapter 20, Penal Code (kidnapping and unlawful restraint);
- (3) an offense under Section 21.02, Penal Code (continuous sexual abuse of young child or children), Section 21.11, Penal Code (indecent exposure with a child);
- (4) an offense under Section 22.011, Penal Code (sexual assault);
- (5) an offense under Section 22.02, Penal Code (aggravated assault);
- (6) an offense under Section 22.04, Penal Code (injury to a child, elderly individual, or disabled individual);
- (7) an offense under Section 22.041, Penal Code (abandoning or endangering child);
- (8) an offense under Section 22.08, Penal Code (aiding suicide);
- (9) an offense under Section 25.031, Penal Code (agreement to abduct from custody);
- (10) an offense under Section 25.08, Penal Code (sale or purchase of a child);
- (11) an offense under Section 28.02, Penal Code (arson);
- (12) an offense under Section 29.02, Penal Code (robbery);
- (13) an offense under Section 29.03, Penal Code (aggravated robbery);
- (14) an offense under Section 21.08, Penal Code (indecent exposure);
- (15) an offense under Section 21.12, Penal Code (improper relationship between educator and student);
- (16) an offense under Section 21.15, Penal Code (improper photography or visual recording);

- (17) an offense under Section 22.05, Penal Code (deadly conduct);
- (18) an offense under Section 22.021, Penal Code (aggravated sexual assault);
- (19) an offense under Section 22.07, Penal Code (terroristic threat);
- (20) an offense under Section 32.53, Penal Code (exploitation of child, elderly individual, or disabled individual);
- (21) an offense under Section 33.021, Penal Code (online solicitation of a minor);
- (22) an offense under Section 34.02, Penal Code (money laundering);
- (23) an offense under Section 35A.02, Penal Code (Medicaid fraud);
- (24) an offense under Section 36.06, Penal Code (obstruction or retaliation);
- (25) an offense under Section 42.09, Penal Code (cruelty to livestock animals) or under Section 42.092, Penal Code (cruelty to nonlivestock animals); or
- (26) a conviction under the laws of another state, federal law, or the Uniform Code of Military Justice for an offense containing elements that are substantially similar to the elements of an offense listed under this subsection.

(b) A person may not be employed in a position the duties of which involve direct contact with a client in a facility or may not be employed by an individual employer before the fifth anniversary of the date the person is convicted of:

- (1) an offense under Section 22.01, Penal Code (assault), that is punishable as a Class A misdemeanor or as a felony;
- (2) an offense under Section 30.02, Penal Code (burglary);
- (3) an offense under Chapter 31, Penal Code (theft), that is punishable as a felony;
- (4) an offense under Section 32.45, Penal Code (misapplication of fiduciary property or property of a financial institution), that is punishable as a Class A misdemeanor or a felony;
- (5) an offense under Section 32.46, Penal Code (securing execution of a document by deception), that is punishable as a Class A misdemeanor or a felony;
- (6) an offense under Section 37.12, Penal Code (false identification as peace officer); or
- (7) an offense under Section 42.01(a)(7), (8), or (9), Penal Code (disorderly conduct).

In addition, Integral Care will not enter into a Contract with an Applicant that:

1. Has been convicted of other types of criminal offenses that may be considered a contraindication to contracting with Local Authority, in Local Authority's sole discretion;

2. Is listed as “revoked” in the Nurse Aide Registry;
3. Is listed as “unemployable” in the Employee Misconduct Registry; or
4. Is listed as having a confirmed finding with CANRS.

(c) In addition to the prohibitions on employment prescribed by Subsections (a) and (b), a person for whom a facility licensed under Chapter 242 or 247 is entitled to obtain criminal history record information may not be employed in a facility licensed under Chapter 242 or 247 if the person has been convicted:

(1) of an offense under Section 30.02, Penal Code (burglary); or

(2) under the laws of another state, federal law, or the Uniform Code of Military Justice for an offense containing elements that are substantially similar to the elements of an offense under Section 30.02, Penal Code.

(d) For purposes of this section, a person who is placed on deferred adjudication community supervision for an offense listed in this section, successfully completes the period of deferred adjudication community supervision, and receives a dismissal and discharge in accordance with Article 42A.111, Code of Criminal Procedure, is not considered convicted of the offense for which the person received deferred adjudication community supervision.

No Applicant will be permitted to become a Contracted Provider if the Application is falsified in any way.

A Contract will be terminated if the Contracted Provider has provided false information regarding the Application or the Services.

Attachment C: E-Verify

E-verify is an Internet-based system that allows businesses to determine the eligibility of individuals to work in the United States. Integral Care requires proof of US citizenship and/or other legally sufficient authorization to legally work in the United States. Organizational Applicants are required to submit I-9 verification information through the E-verify system on each organizational group member applying for credentialing under the Application. Individual Applicants will be required to show original I-9 documents and sign the I-9 form in person at Integral Care. For a list of acceptable I-9 documents go to: <https://www.uscis.gov/i-9-central/acceptable-documents>. Integral Care will provide the Social Security Administration (SSA) and, if necessary, the Department of Homeland Security (DHS) and/or other appropriate agencies, with information from each prospective individual contractor's Form I-9 to confirm work authorization through the E-verify System.

Attachment E: Safe Driving Standard – Poor Driver Guidelines

Listed below are guidelines that the Texas Council Risk Management Fund, which provides liability insurance for Integral Care, follows to determine whether someone is a “poor driver” from review of the motor vehicle record or driver’s record from the Texas Department of Public Safety (“MVR”). These guidelines apply to any Contracted Provider and their employees who will drive an automobile that transports Clients as either a part of or incidental to any Services.

If any Contracted Provider or its employees has four (4) or more points based on the list below, they CANNOT TRANSPORT CLIENTS.

Based on a point system, a driver with four (4) or more points (as indicated below) is considered a “poor driver.” Organization Applicants who intend to provide services through its employees need to request each such employee’s driver record from the Texas Department of Public Safety and review those records against the guidelines above. Applicants who are not Organizations must request their own Texas DPS driver’s record and submit a copy to Integral Care’s Credentialing Department. Here are the guidelines used to determine a “poor driver”.

Guidelines – Based on Citations During the Previous Three (3) Years

At-fault accident (not applicable if driver provides an accident report showing that driver was not at fault)	2 points
Moving violation	1 point
No <i>Motor Vehicle Insurance</i> violation	2 points
Driving while intoxicated (DWI)	4 points
Driving under the influence (DUI)	4 points
Incidents involving BOTH an at-fault accident AND a moving violation	2 points
Incidents involving two or more moving violations on the same day	1 point

Incidents involving a <i>No Motor Vehicle Insurance</i> violation and a moving violation on the same day	2 points
Incidents involving BOTH an at-fault accident AND a <i>No Motor Vehicle Insurance</i> Violation	4 points
Drug Offense	4 points
All MVRs that come back with a driver's license status of EXPIRED, DENIED, CANCELLED, SUSPENDED, or REVOKED	Automatic Exclusion
